Barrier and Roundbox Restructure Former Hard Rock Park

*Theme Park Emerges from \$400 Million Bankruptcy;
Successfully Reopens as Freestyle Music Park*

DALLAS and WINTER PARK, FL (May 29, 2009) – Barrier Advisors, a Dallas-based financial advisory and restructuring firm, together with Roundbox™ Advisors, a Florida-based financial and strategic advisory firm, today announced the successful restructuring of the former Hard Rock Park, a 135-acre music-themed entertainment property in Myrtle Beach, South Carolina. Operating under new ownership, the park, rebranded Freestyle Music Park, successfully reopened on Memorial Day weekend and plans a grand opening celebration on June 12.

Following Hard Rock Park's chapter 11 filing in September 2008, Roundbox Advisors partnered with the park's original Myrtle Beach investors to acquire Hard Rock Park out of bankruptcy. Serving as financial advisor and a principal in the transaction, Roundbox teamed with Barrier in November 2008 to help navigate the bankruptcy process. While negotiations were underway with the banks and bondholders, Barrier and Roundbox worked together to structure a bid that was acceptable to Hard Rock's senior lenders and bankruptcy trustee.

Working in tandem, Barrier focused on the bankruptcy and restructuring issues while Roundbox developed strategic and financial plans for the park, organized a seasoned management team and secured the \$39 million in financing necessary to acquire and reopen the park. The park now operates under a joint venture called FPI MB Entertainment, LLC.
